LOUNGE: 15'8 X 11'3 (4.78m X 3.43m) Entrance from glass panelled internal door, double aspect with UPVC double glazed windows to front and rear, the later having further secondary glazing, T.V. socket. two radiators, dimer switch to light, coved and textured ceiling.

BEDROOM ONE: 12'2 x 9'3 (3.71m x 2.82m) UPVC double glazed window to front radiator below, range of wardrobes,

BEDROOM TWO: 9'1 (plus recess) x 6'9 (2.77m x 2.06m) UPVC double glazed window to front, radiator below, built in double wardrobe with cupboards over.

KITCHEN: 10'9 x 6'6 (3.28m x 1.98m) Stainless steel sink inset to working surfaces unit with cupboards below, fitted range of base and wall mounted cabinets providing shelf and storage space, washing machine, fridge/freezer, dishwasher and cooker to remain, working surfaces with tiled splash back, gas central heating boiler, radiator, ceramic tiled floor.

BATHROOM/ W.C: Panelled bath with independent electric shower over and shower screen, pedestal wash hand basin, low flush w.c. tiled walls, heated towel rail, UPVC double glazed frosted glass window, tiled floor.
